1. The **Sandakpur Rural Municipality, Office of Rural Municipal Executive Mabumod, Deurali, Ilam, 1 Province, Nepal** invites sealed bids from eligible bidders for Chapgairi Chhange Aalubari Adhikari bikhe bhanjayang second phase Road Construction work.

2. Eligible bidders may obtain further information and inspect the Bidding Documents for Procurement of Goods at mentioned above office, Ph No: 9841899063, or may visit PPMO website www.bolpatra.gov.np/egp.

3. The Bidding document, in English language, will be made available to eligible bidder on the submission of a written application along with the copy of company/firm registration certificate and tax clearance certificate of FY 2074/075 from Office as mentioned in Para 1 upon payment of amount of a non-refundable fee of **NRs 3000.00 (NRs Three Thousand only)** on or before the office hour until **28 Apr, 2019**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. **1000.00 (NRs One Thousand only)** However, the Employer will not be responsible for delay or non-delivery of the documents so sent. The method of payment will be in cash. The document can be purchased by the bidder or his/her authorized representative. For the purpose of Bidders who choose to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site: www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the office's **Rajaswa (revenue) account as specified below** and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np/egp> as specified in the Instruction to Bidders. Bids will be opened physically and electronically at **13:00 hrs of 29 Apr, 2019** in the presence of the bidders' representatives who choose to attend at mentioned office. Documents received after this deadline shall not be accepted.

5. Bid must be accompanied with bid security Amount mentioned in Para 8 and it should be in the form of Bank Voucher deposited in the deposit account No: 19000201100100000004, at Prabhu Bank Limited, Sandakpur branch, Ilam or Bank guarantee drawn in favor of this office, having a validity period of 90 days from the last date of submission of the bid. Bid security must remain valid for 30 days after the bid validity period.

6. A pre bid meeting will be held on **21st Apr, 2019 at 2:00 hrs** at the office mentioned in Para 1. All interested bidders are encouraged to visit the site and attend the pre-bid meeting. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.

7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
