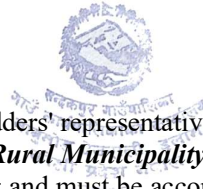

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 pm, 10th Sep. 2026 (25 Bhadra 2083)** at the office of **Sandakpur Rural Municipality, Mabumod, Deurali, Ilam** . Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **2,50,000/-**, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
